We have also recently been a springboard for discussions about making Ugborough more sustainable.

We are so lucky to have a group of people who genuinely care about USS and show it through helping to set up the hall in the morning and at close of the day. Many hands definitely make light work and I want to take this opportunity to say thank you very much to all those who help out. Without Kate Brampton we would not have a Bring and Buy stall. Her kind and generous personality allows USS to store the items in her house in between each Sustainable. Election of Committee:

Clive is resigning as Treasurer. There were 2 nominations to take over, Phil Hart and Juliet Collis. The nominees were asked to leave the room while those present voted. Juliet was voted in by a show of hands (7 votes to 3 votes).

Val is happy to continue as Secretary. Proposed by Sarah, seconded by Yvonne

Vici is happy to continue as Volunteers Co-ordinator. Proposed by Kate, seconded by Phil.

Any Other Business:

- Our Constitution has recently been looked into after 6 years in existence. We operate as an Unincorporated Community Association, ie as facilitators for USS
- It is the producers own responsibility to have liability insurance if they so wish
- Eric Cowsill is checking the Constitution
- Sue Stewart said it was important to be careful about allergens in food
- Food Hygiene certificates can be found online at a cost of approx £20, and food producers will be encouraged and helped to obtain one, if they don't already have a certificate
- Sarah has produced an Allergens Chart which will be given to all new producers
- Kate pointed out that ingredients needed to be shown on any food produced for consumption in the village hall for insurance purposes, ie for Pot Luck Suppers

Open Forum:

- Vici gave a vote of thanks to Sarah for her work to date, and for agreeing to stay until a replacement is found. She was given a round of applause by the meeting
- Sue Stewart wanted to thank the committee for facilitating USS, and said she loved coming along on Saturdays

Next Committee meeting:

There was a brief committee get together after the AGM, and we will meet again on Thursday 4th October at 4.00pm at Sarah's house
